

RECIPE OF THE MONTH – JEFF'S SMOKED BRISKET

INGREDIENTS: Biggest and meatiest brisket

The Night Before

- 1. Trim as much fat off as you prefer, but be sure to leave at least ¹/₄ inch of fact on the bottom.
- 2. Season the brisket with salt and pepper ... Jeff calls this "Texas Style"
- 3. Refrigerate it overnight.

Day of

- 1. Pre-heat the smoker to 250 degrees. It should take about 45 minutes.
- 2. Place the brisket on the counter and allow it to reach room temperature.
- 3. When smoker reaches 250 degrees insert thermometer into thickest part of the meat.
- 4. Add your desired wood chips and smoke until it reaches 165 degrees internally. (*Add wood chips ever 3 hours thereafter.*)
- 5. Remove brisket and wrap in foil to keep moisture in, re-insert thermometer and smoke until it his 200 to 205 degrees.
- 6. Place the brisket (still in foil) in a thermal bag or the oven to allow it to soak the juices back up.
