Tip of the Month - Protect Your Children from the Unthinkable

As a new father, I've had to think about taking care of my wife and daughter in the event that something happens to me so that we can avoid unthinkable events. And in the event of the death of one or both parents, and without advance legal planning, unthinkable events can and do take place:

- Your children could be placed into the care of Child Protective Services and, even though it
 would very likely only be temporary, you never want your children in the arms of strangers.
 Note even for a minute. OR
- Your children could be put into the custody and care of someone you would never want, like that one family member who has good intentions, but you'd never want raising your kids.

If something happens to one or both parents...

- A judge who doesn't know you, or your family, will decide who will raise your kids, even if it's the last person you would ever want.
- Your family could get into a long, drawn out custody fight or there could be a challenge to the guardians you have designated.
- Up to 3% of the value of your assets could be lost to court costs and other unnecessary fees
 through the probate process, court process that can tie up your assets for years and deprive
 your kids of the resources they need to live comfortably, which can totally be avoided with
 advance legal planning.
- When your kids turn 18, they get a check for whatever assets are left. There are unscrupulous people out there who make it their business to look at the public records to find out when 18 year old's are getting that inheritance check.

RECIPE OF THE MONTH - BACON WRAPPED DATES STUFFED WITH BLUE CHEESE

INGREDIENTS:

- 1-pound sliced bacon, cut in half
- 1-pound pitted dates
- 4 ounces blue chees

DIRECTIONS:

- Preheat the oven to 375 degrees F (190 degrees C).
- Slice dates in half, and open them up. Pinch off pieces of blue cheese, and place them into the center of the dates. Close the halves of the dates, and wrap a half-slice of bacon around the outside. Secure each one with a toothpick. Arrange in a baking dish or on a baking sheet with sides to catch any grease.
- Bake for 30 to 40 minutes in the preheated oven, or until the bacon is crisp. Turn dates over after the first 20 minutes for even cooking.


