The Neighborly Approach for Dealing with Unreasonable Neighbors

We all want good neighbors, but it's hard to know how to be the kind of neighbor our neighbors want. Depending on personal preferences, being neighborly might mean staying invisible except for a quick wave while getting the mail. Or you might think of someone being a good neighbor when he or she is available to help out with any unexpected need. But this is highly dependent on everyone's personality.

So here are some strategies when dealing with the unreasonable neighbor, you know the one that's causing you a ton of grief...

- Be Polite – nobody likes a jerk, especially if you have to see them every day.
- Be Reasonable – if you really want to get along you may offer to split the costs. Remember you are neighbors.
- Order/Organize your priorities – with this strategy you are ranking all the issues and concerns. This allows both sides to know what the full set of options really are.
- Be willing to Give in - keep in mind that the goal of negotiation is mutual satisfaction, so maybe you can offer something else to mend the relationship.
- Make an offer - for purchase of the problem area or an offer to sell it. This may sound strange, but it will eliminate the problem all together.
- Share Information – although you may want to be guarded and wary of “showing your hand,” sharing information is in line with the Golden Rule “do to others what you want them to do to you.”

Make a Moral Appeal –. Try to make a moral appeal to trigger a sense of fairness. And if it doesn't work, at least you know that you tried.


